




## THE OPPORTUNITY: THREE PRIME PARCELS AVAILABLE

- Located within the County of Strathcona Capital Regions Priority Growth Area.




## **EDMONTON & SURROUNDING AREA TRUCK ROUTES**


HIGH LOAD CORRIDOR ROUTES
