2022 SITE IMPROVEMENTS

Established in 1944, FCL is owned by over 160 independent retail co-operative across Western Canada, collectively forming the Co-operative Retailing System (CRS). This network operates more than 1,600 locations, including agro centres, food stores, gas bars/convenience stores, and home centres, serving over 2 million active members. In 2021, FCL expanded its energy sector presence by acquiring 181 Husky-branded retail fuel sites across Western Canada for \$264 million which included 6309 44th Street, Lloydminster.
