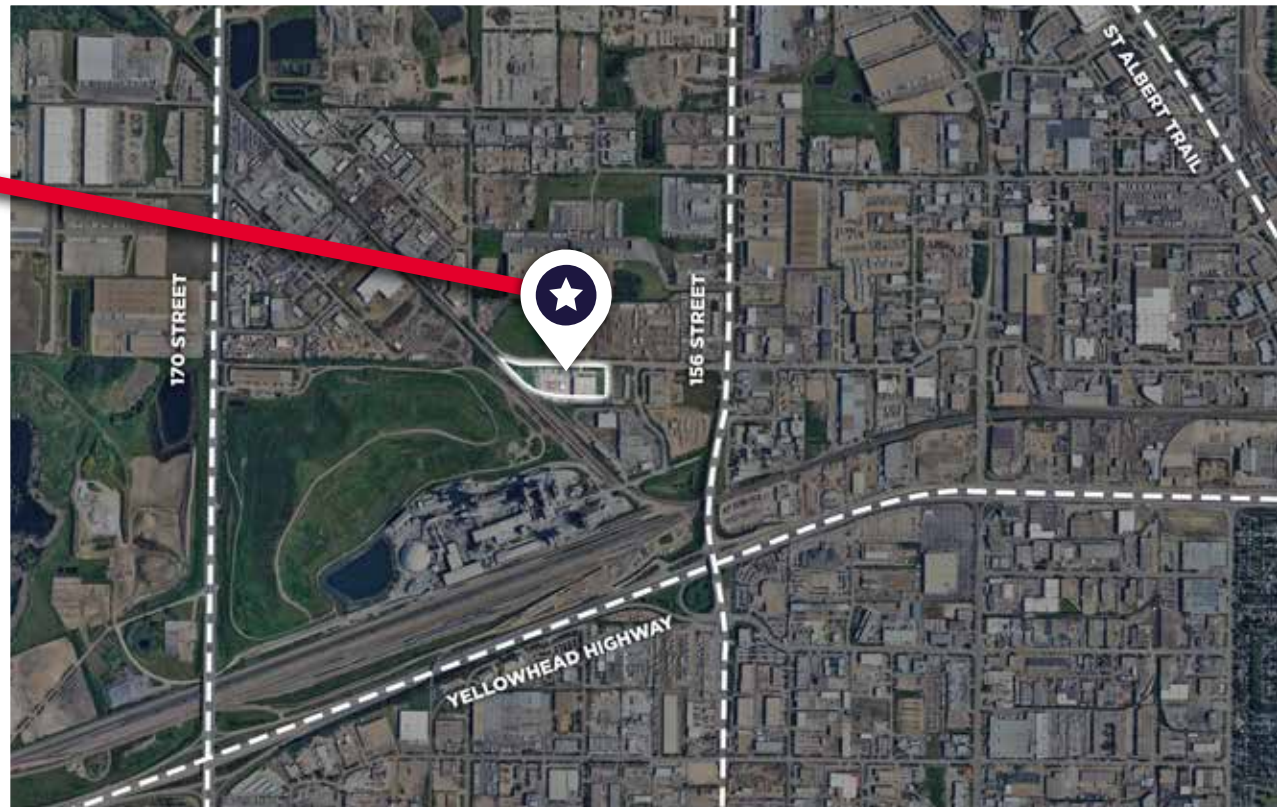

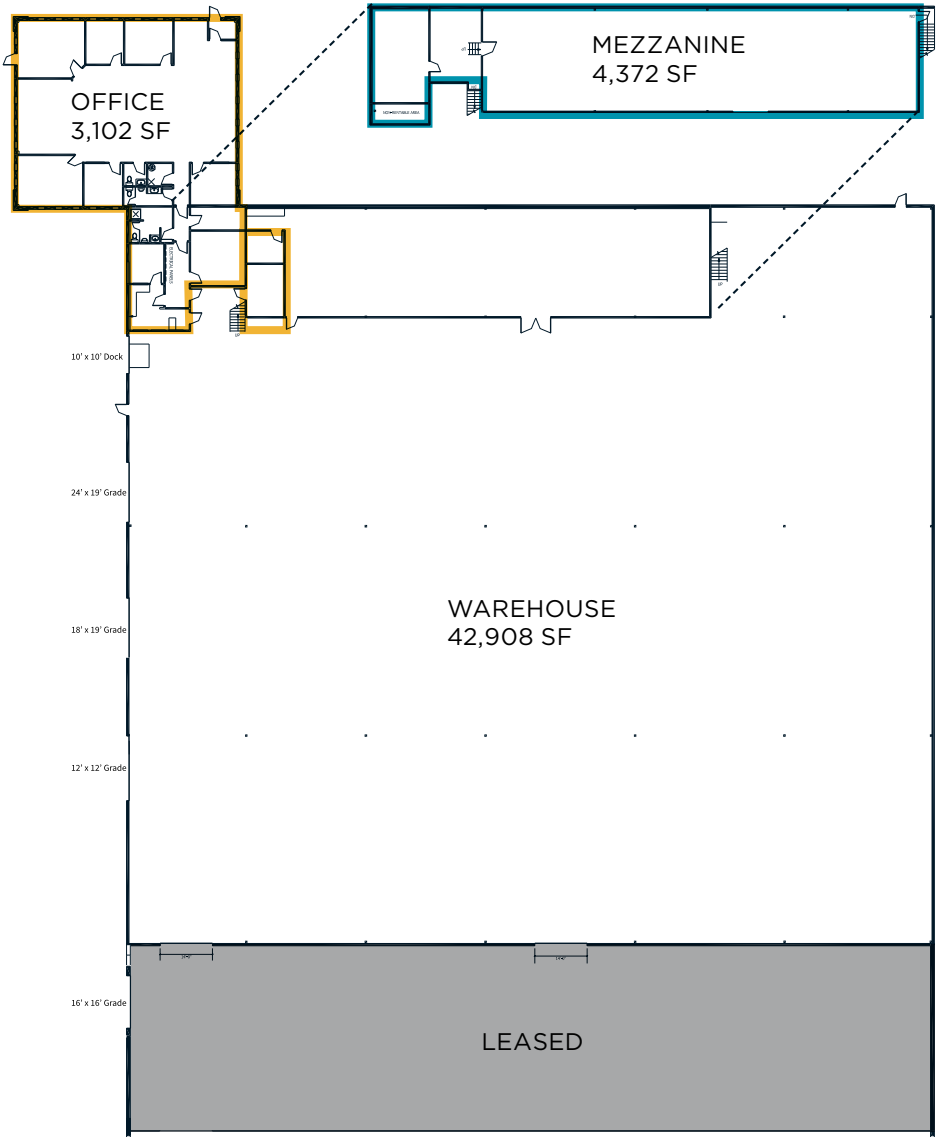

SITE PLAN



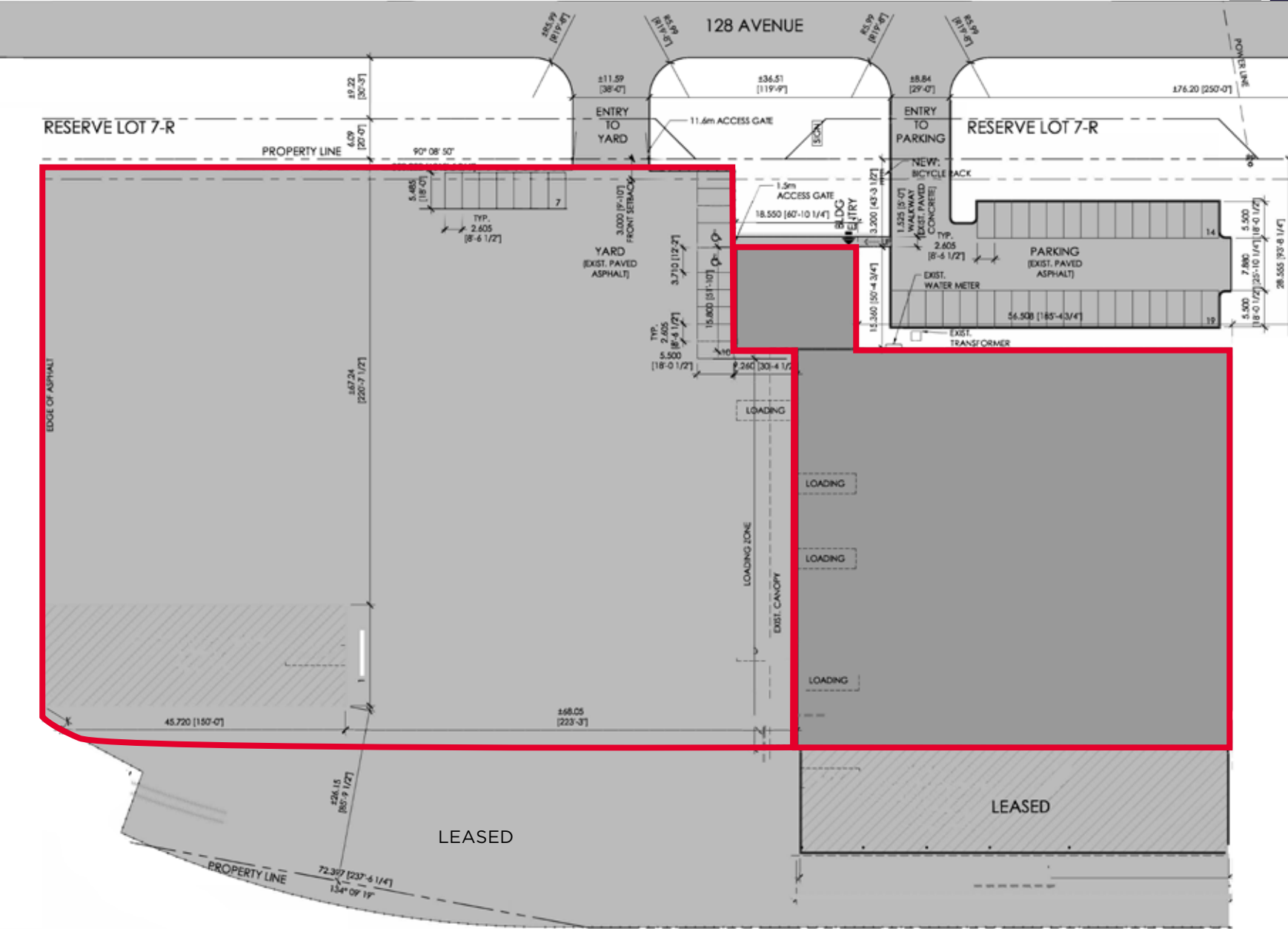

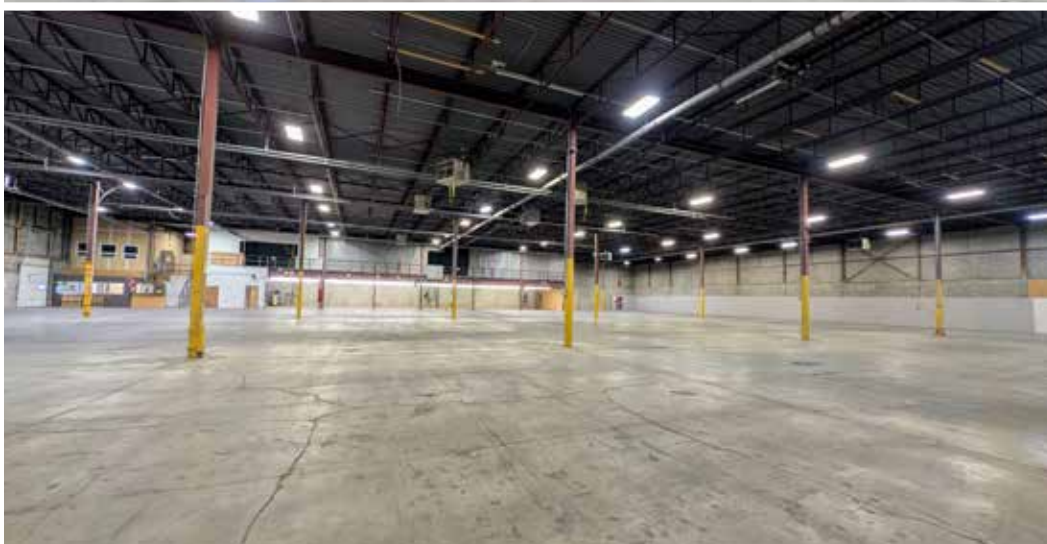
